By using our Website or placing an order, you agree to these Terms and Conditions and represent that you are legally able to purchase firearms and related items in your jurisdiction.

## 1. Eligibility

You must be:

- At least **21 years old** to purchase handguns or handgun ammunition.
- At least **18 years old** to purchase long guns or long gun ammunition.
- Not prohibited from owning firearms or ammunition under **federal, state, or local law**.

By placing an order, you certify that all information is truthful, and you meet all legal eligibility requirements.

## 2. Compliance with Laws

We comply with all applicable **Florida, federal, and local** laws, including:

- The Gun Control Act of 1968 (GCA)
- National Firearms Act (NFA)
- ATF regulations
- Florida Statutes on firearm transfers and ownership

It is your responsibility to know and comply with your local laws regarding firearm and ammunition ownership.

### 3. Firearm Sales

- All firearms must ship to a **Federal Firearms Licensee (FFL)**.
- You must provide the contact details of a receiving FFL during checkout.
- You must complete a **background check** and any applicable **waiting period** in person at the FFL location.
- We will not ship firearms directly to consumers.

We reserve the right to cancel any firearm order that violates any law or seems suspicious.

---

### 4. Ammunition Sales

We ship ammunition in accordance with all federal and Florida laws. However:

- We do not ship ammunition to jurisdictions where prohibited (e.g., certain areas of CA, NY, IL, DC).
  - You may be required to provide proof of age or a permit where applicable.
  - No returns are accepted on ammunition.

### 5. Accessories

Accessories that are not regulated (e.g., scopes, holsters) may be shipped directly to consumers unless otherwise restricted by local laws.

### 6. Order Acceptance

We reserve the right to:

- Refuse or cancel any order for any reason.
- Limit quantities or restrict sales to certain areas.

Order confirmation does not constitute final acceptance. We may require additional verification before shipment.

## 7. Returns and Refunds

- **Firearms and ammunition are non-refundable and non-returnable.**
  - Accessories may be returned within **30 days**, unopened and unused.
  - Customers are responsible for return shipping unless the item was defective or incorrect.
